Rules of Conduct

The Rules of Conduct for Princesses are the foundation upon which the images and reputation of the Miss Clatsop County Princess Program is being built and will continue to be the basis for its operation.

- Miss Clatsop County Princesses will conduct themselves at all times with the dignity, grace and good manners of young women who exemplify the integrity of American youth. A Princess must observe all rules and regulations at all meetings, rehearsals, events and performances.
- Princesses will not participate in any interview, picture, press contact or any type of publicity unless a member of the Miss Clatsop County Board is present.
- A Princess may not represent Miss Clatsop County at parties, meetings and social events or make any public appearances other than official Miss Clatsop County events.
- When you leave all events, activities and meetings you must check out with a princess committee member.

Infraction of Miss Clatsop County Princess Rules of Conduct

If Princess conduct is deemed unsatisfactory by the Chairman of the Princess Committee or Executive Director of the Miss Clatsop County Scholarship Program and by this conduct the image and good name of the Miss Clatsop County Princess Program is deemed jeopardized, the following procedure is followed: The Chairman of the Princess Program Committee will issue a warning to the Princess in the presence of another Pageant Official. The Princess parent will be notified immediately. If the condition causing this warning is corrected, no further action will be taken. If the condition is not corrected, the Chairman of the Princess Committee will notify the Executive Director of the Miss Clatsop County Scholarship Program. He/she will be given all particulars regarding the infraction of rules; further action would be the result of their decision. What a Miss Clatsop County Princess does, where she goes, and how she conducts herself while representing the Miss Clatsop County Scholarship Program are all governed, to a large degree, by rules, regulations, and demanding schedules.
